In consideration of being allowed to participate in a shooting contest ("the match") on the date noted below, I hereby release Lewiston Pistol Club, Inc., an Idaho non-profit corporation, its officers, directors, members, and agents and the sponsors, promoters, and officials of the match ("the club") from all liability that may arise from any loss, damage, or injury, including death, that I may sustain as a result of my participation the match, acknowledging that such liability may arise from a negligent act or omission of the club, from dangerous or defective equipment or property owned, maintained, or controlled by the club or because of the club's possible liability without fault.

DESPITE THIS KNOWLEDGE OF THE DANGER INVOLVED, I ELECT VOLUNTARILY TO PARTICIPATE IN THE MATCH**

I voluntarily assume all risks of loss, damage, injury or death which may result from my participation the match including the risks inherent in the discharge of firearms with live ammunition as well as those caused by dangerous or defective range conditions, facilities, or equipment, inclement weather, extremes of temperature, and the actions of other people including match officials and other participants in the match. I hereby represent that I have previously acquired the knowledge, skills, and attitude necessary to safely compete in the match. I understand that neither the club nor other competitors are able to assess the adequacy of my prior training.

In signing below, I acknowledge I am over 18 years of age and represent that I have read and understand this participation release and agreement and freely enter into it on behalf of my distributees, heirs, next of kin, executors, and administrators. I agree to observe all range rules and to abide by all rulings made by match officials.
